Introduction

Cantor Fitzgerald Investment Advisors (CFIA) is registered with the Securities and Exchange Commission as an Investment Advisor. Brokerage and investment advisory fees differ, and it is important for the retail investor to understand the differences. Free and simple tools are available to research firms and financial professionals at [Investor.gov/CRS](https://www.investor.gov/CRS), which also provides educational materials about broker-dealers, investment advisers, and investing.

What investment services and advice can you provide me?

Our firm offers investment advisory services to retail and institutional investors. If you open an advisory account, you will pay an on-going **asset-based fee** each quarter for our services, based on the value of the cash and investments in your advisory account.

Efficient Market Advisors (EMA), a business of Cantor Fitzgerald Investment Advisors, will utilize both in house and third-party research to construct Exchange Traded Fund (ETFs) model portfolios. We will review your investment goals and decide with you a model portfolio to achieve your investment goals. In addition, we will regularly monitor your account and will offer you advice on a regular basis. You should regularly review your portfolio with your financial advisor or with EMA. Our investment advice will cover a significantly limited selection of investments. Our model portfolios will be comprised of only ETFs. Other firms could provide advice on a wider range of choices, some of which might have lower costs.

Flippin, Bruce & Porter (FBP), a business of Cantor Fitzgerald Investment Advisors, will provide advisory services utilizing a value approach with a focus on dividend yield and covered call option premium cash flow. We choose from a variety of securities to build investment portfolios which include, and are generally limited to, the following: publicly traded equities, corporate debt securities, municipal securities, mutual funds, exchange-traded funds (ETFs), money market instruments and covered call options. We provide advisory services to two mutual funds, the FBP Appreciation & Income Fund and the FBP Equity & Dividend Plus Fund. We also manage accounts as an adviser, subadvisor and/or research provider to sponsored, all-inclusive asset-based fee programs referred to as “wrap fee” programs. Portfolio-modeling research and retirement account consulting services are also offered on a limited basis

Your contract allows us to buy and sell investments in your account without asking you in advance (a “**discretionary account**”).

What fees will I pay?

The amount paid to our firm does not vary based on the type of model portfolio EMA will select on your behalf. The **asset-based fee** reduces the value of your account and will be deducted from your account. An ETF can impose additional fees that will reduce the value of your investment over time.

The FBP managed wrap fee program account fees include our advisory fee, execution charges on trades and custody fees. Wrap fee program account fees are asset-based fees and vary by program sponsor. Account consulting service fees are billed at a negotiated hourly fee.

Our fees vary and are negotiable. The amount you pay will depend on the amount of assets in your account.

You will pay a transaction fee when we buy and sell an investment for you. You will also pay fees to a broker-dealer or bank that will hold your assets (called “custody”).

The more assets you have in the advisory account, including cash, the more you will pay us. We have an incentive to increase the assets in your account in order to increase our fees. You pay our fee quarterly even if you do not buy or sell.

Third-party vendors (e.g., product sponsors, custodian, Technology firms, mutual fund companies) may offer EMA employees financial assistance in the form of marketing reimbursement, complimentary, or a discounted cost in attending a conference or due diligence trip. The reimbursement allows a third-party vendor to help EMA grow their client base or to be educated current market new, platforms, technology, and various financial products.

We sponsor and manage the FBP Appreciation & Income Opportunities Fund and the FBP Equity & Dividend Plus Fund. Our retirement plans, as well as our employees, may be shareholders of these funds. We may recommend that you invest in these funds as an alternative to investing in an independently managed account. Firm employees may also have an interest or position in securities recommended to you.
